TERA Year End Awards Program

All award recipients must be TERA members in good standing for the year for which the awards are being given. Awards are figured based on TERA sponsored rides only. Limited Distance and Endurance miles are calculated as separate mileages.

Overall High Mileage Rider is based on the mileage completed by one rider riding any number of equines.

Overall High Mileage Horse is based on the mileage completed by one equine with any number of riders.

The following awards are based on the mileage completed by one rider riding one equine:

Limited Distance High Mileage
High Mileage Featherweight
High Mileage Lightweight
High Mileage Middleweight
High Mileage Heavyweight
High Mileage Junior

High Mileage Husband/Wife award is given to the couple with the most combined mileage ridden.

High Mileage Family award is based on the total miles ridden by two or more family members.

The following awards do not have to be given every year. These recipients are chosen by the Board of Directors and Officers

Rookie Rider of the Year

New to the sport, may be endurance and/or limited distance; number of completions; positive attitude; seeking knowledge of the sport; overall contribution to the sport; and improvement/progression.

Volunteer of the Year

Support at TERA rides; contribution to TERA, riders, and equines; number of rides attended; positive feedback from riders, managers and other volunteers; support/promotion of the sport. Rider or non-rider.

Veterinarian of the Year

Contribution to TERA, TERA members and equines; number of TERA rides vetted; positive feedback from riders, managers, animals and volunteers, support/promotion of the sport; seeking knowledge and improvement in skills related to the sport, encouragement/education to riders, participants, one-time spectacular contribution (saving animal/human life, etc.)

Ride Manager of the Year

Safe, well-marked trail; superior organization—camp, registration, P/R and vet checks, availability of professional emergency personnel and equipment,

general flow of things, etc; level of commitment—extra events, unique prizes, more than one ride, attendance at ride manager clinics; adequate vet staff—number of vets per riders, introduction & preparation of new vets; overall—sizable ride, new riders, and positive feedback.

Horse and Rider of the Year

TERA member & equine, but not limited to TERA events only, spectacular achievement, may be any distance; embodies spirit of AERC “To Finish Is To Win!” in relationship of mount and rider—concern of horse foremost; competitive but fair & honest.

Hall of Fame Person

Longterm contribution to sport; best exemplifies “To Finish Is To Win!”. Person must also have been officer, director, ride manager, regular volunteer, regular vet, etc. – someone who has given to the sport and TERA; does not have to be a rider.

Hall of Fame Equine

Cumulative lifetime achievement. Perhaps has overcome adversity and continued on. The horse people remember and talk about.

TERA Spring Meeting Minutes

18 August 2007

Parrie Haynes Ranch, Killeen Texas

President Dianne Campbell called the meeting to order. Officers Present: President Dianne Campbell; Vice Pres Ann Goolsby; Treasurer Donna Nicholson; Secretary Deb Stewart BOD Present: Kim Reeves, Debbie Allen, Nick Nicholson, Dawn Carrie

Minutes from the Fall Meeting were read by the secretary and accepted by membership.

Donna Nicholson gave the treasurer's report; details of the report will be listed in the newsletter.

OLD BUSINESS:

Road Conditions for Old Glory were discussed for next year. Conditions are expected to be much improved by ride time next year.

NEW BUSINESS:

TERA awards in the past have been presented at the Central Region convention. Last year the awards were presented at 7IL with favorable comments. The hotel in Henrietta was not up to standard. In addition, most Texas people do not go to the Central region convention. It was received favorably to have it in Texas where most riders will be present and they can get their awards in front of their peers. Contrary to this discussion was the fact that having it in Oklahoma would bring all Central Region people together especially those from the northern region states. A suggestion was made to alternate sites so all regions could benefit. Another suggestion was made to combine the awards by presenting the physical awards at a TERA ride and sending a representative to the Central Region convention to read the TERA awards there. Two motions were made to accept the 7IL location for this year's awards and send a representative to the Central Region convention. Both motions were passed.

A motion was made to investigate the cost and establish a committee to move the central region convention to Texas in 2009. Motion was passed. The Convention committee was chosen and approved by TERA membership. Members are Vicki Holzer-chairperson, Chris Godsey-member, Kristen Fisher-member, (Paulette Brehob and Peter Ansorge will be asked if they will also serve on the committee). The committee will report their progress at the 7IL TERA meeting.

A motion was made to consider making TERA rides cross sanctioned with AHA. Details and what needs to be done to make it legal will be researched and reported at the Fall meeting. Motion passed.

Starting December 1, 2007, a TERA sanctioning form will be established and placed on line. The draft will be presented at 7IL. This form will aid RM's who want TERA sponsorship for their rides.

The membership was informed that board members voted on purchasing a Laptop Computer for TERA. It will be maintained by the treasurer.

Also discussed were the new awards. Details will be presented at the Fall meeting.

Discussions were held on having a separate TERA convention. Further discussions on this topic will be put on hold until the previous motions for TERA awards and Central Region convention locations have been resolved. The Convention committee will also investigate the possibility of a separate convention.

Everyone was reminded that TERA has a web site accessible to all members.

Ride & Tie was discussed. The first attempt will be at the Heart of the Hills. More to follow.

Motion was made to adjourn at 1:55 PM.

MINUTES OF THE TERA BOARD MEETING HELD 18 AUGUST 2007 PARRIE HAYNES RANCH, KILLEEN TEXAS

The TERA board meeting was held at Parrie Haynes Ranch. The meeting was opened at 8:15 AM by TERA President Dianne Campbell. Officers present were Dianne Campbell, Ann Goolsby, Deb Stewart, Donna Nicholson, BOD members present were Nick Nicholson, Dawn Carrie and Kim Reeves.

The following topics were discussed:

Belt Buckles

The first order placed for TERA belt buckles is 200 buckles at a cost of \$2470.00. It will take 4-6 weeks to receive them. An example was shown to board members. Treasurer Donna Nicholson confirmed there are sufficient funds to purchase the belt buckles. The suggestion was made to present them as end of year awards. The motion was made and approved to order the 200 buckles.

2007 TERA Awards

The suggestion was made to bring up at the General membership meeting to do TERA awards at 7IL this year. All agreed to bring it up at the meeting in the afternoon. If the general membership approves the suggestion then approval will be requested from the 7IL ride manager to hold the TERA awards at 7IL.

TERA Convention

A suggestion was made to have TERA hold its own convention at a future date. More research is needed to see the plausibility and possible costs associated with it.

Fund Raiser

A discussion was held to hold an additional ride at Parrie Haynes ranch as a fund raiser for TERA. Dianne will talk to Parrie Haynes ranch to possibly do the trails and Dianne will do the AERC coordination. Treasurer stated that we do not make much, if any, extra money on the fund raiser but we break even. Suggestion was made to make it a two day ride in cooler weather.

TERA Sanctioned Rides

A form will be developed and sent to board member for approval. Once the format is approved the form will be available on the TERA web site.

Laptop Computer

A motion was made to purchase a Laptop computer for TERA. The computer would be maintained by the Treasurer to load awards, treasurer info etc. Board members voted to approve the purchase.

Tax ID number for TERA as a Charity Exemption

The cost to establish a legal account would cost about \$1000.00. We would need to establish a corporate account under a different name; however, we could still use the TERA name. The board agreed to not pursue this issue unless a TERA member who is a tax attorney would volunteer their time to aid in establishing an account; otherwise it is cost prohibitive.
